With the installation of the North 43 Lagoon Commission Gunn Regional Sanitary System, there are important mandatory requirements that all landowners must be aware of before having their sewage pumping system connected to the North 43 Lagoon Forcemain. Please note, it is the responsibility of each property owner to contract a qualified company to install the approved pumping system in the approved holding tanks.

Steps to connect your sewage pumping system to the North 43 Forcemain:

1. You must first obtain and submit the proper Permit(s) from your Municipality.
2. Once Permits have been approved by your Municipality, the installation of the North 43 Forcemain approved pumping system can progress. A credible contractor must be hired to install the pumping system, this is the responsibility of the landowner.
3. All proper Safety Code Permits must be secured from approved safety code inspection agencies in the County or Summer Villages. Once the proper permits have been secured, proceed with installation of the pumping system according to Provincial approved practices.
4. Once the installation of your pumping system has been completed, and inspected by one of the approved inspection groups, please have your inspection reports and Municipal Wastewater Application submitted to the applicable municipality.
